P3a. Description:

The property contains a two-story commercial building with a rectangular plan and wood-frame construction. Designed in the Spanish Colonial Revival style, it has a flat roof with clay tiles and a pitched clay tile roof at the front elevation. The exterior walls are clad with smooth stucco. The primary (south) elevation is characterized by two rectangular storefronts on the ground level. Each storefront is composed of an original recessed opening that has been filled with a non-original door and fixed divided-light wood window. An arched wood-paneled door occupies the easternmost portion of the ground level. The upper level exhibits a wide recessed porch with wood balustrades and porch supports, and contains a series of wood doors with divided-light glazing. A similarly-styled door and decorative iron balcony flanks the upper-level porch to the east. A chimney with side flues and a hipped clay tile cap is centered at the roof's ridge line. The fenestration consists of both original and non-original wood windows throughout the building. The building is in good condition. Its integrity is good.


