P3a. Description:

The property contains a one-story single family residence with a rectangular plan and wood-frame construction. Designed in the Spanish Colonial Revival style, it has a low-pitch side-gable roof with clay tiles. The exterior walls are clad with original smooth stucco. The residence is asymmetrical. The southernmost bay of the primary (east) elevation features a projecting bay containing a single-car garage. The bay has a low-pitch front-gable roof with clay tiles and a clay tile parapet. Centered under the front gable is a decorative vent with four intersecting round clay tile openings. A decorative round band of trim runs underneath the roof on its side elevations. The south elevation also features narrow, full-height round arches inset within the wall. The garage door is within a rounded arch opening. A second projecting bay is on the opposite elevation and features a front-gable roof with clay tile parapet above a window opening centered below. Spanish Colonial Revival elements of the residence include the stucco chimney capped in brick and exposed rafter tails. The fenestration consists of non-original double-hung vinyl windows throughout the residence. A low stucco wall encloses a brick patio space with clay tile details, capping the step to the raised patio as well as the stucco wall. At the patio entrance the stucco walls are punctuated by square stucco piers rising slightly above the walls. The residence is in good condition. Its integrity is fair.


