The property contains a two-story residential building with wood-frame construction. The residence has a U-shaped plan arranged around a central courtyard. Designed in the Spanish Colonial Revival style, it has low-pitch hipped roofs clad with clay tiles. A one-story projecting arcade is sheltered beneath a clay tile clad shed roof. The exterior walls are clad with smooth stucco. The fenestration consists of original wood divided-light single- and double-casement windows throughout the residence. The building's eastern elevation fronts the street, while the western elevation overlooks the ocean. Decorative exterior features include arcaded walkways, arched openings.

The portion of the residence at 255 Avenida Lobeiro appears to have been originally designed as a single-family residential building and subsequently converted to its present multi-family use. The adjacent two-story multi-family residential building at 257 Avenida Lobeiro is connected to the main structure by an arched wing wall. This similarly styled adjacent building features differing rooflines and rafter tails, and appears to be a later addition. The main residence is in good condition. Its integrity is good.


