P3a. Description:

The property contains a one-story single family residence with a rectangular plan and wood-frame construction. Designed in the Spanish Colonial Revival style, it has a low-pitch side-gable roof over the main portion and low-pitch front-gable roof with asphalt shingles and clay tile edges over the easternmost bay of the primary (north) elevation. The roof appears to have been altered. The primary elevation is asymmetrically aligned, with the easternmost bay projecting and the center bay, where the main entrance is located, and the westernmost bay setback. The exterior walls are clad with original smooth stucco. The primary facade features a covered entryway under a shed roof. Fascia board encloses the residence's rafter tails. Another feature of the Spanish Colonial Revival style of the residence is the stucco chimney. The fenestration consists of original wood casement and fixed windows throughout the residence. The residence is in good condition. Its integrity is fair.


