

P3a. Description:

The property contains a one-story single family residence with a rectangular plan and wood-frame construction. Designed in the Spanish Colonial Revival style, it has a low-pitch side-gable roof with clay tiles. The portion of the roof above the entryway extends to cover the entry porch on the primary (west) elevation. The entryway includes wood porch supports and a wood trellis structure that extends along the entire elevation. The exterior walls are clad with original smooth stucco. The residence is asymmetrical. The garage bay of the residence extends off of the north elevation and has a flat roof with clay parapet. The garage bay is setback from the rest of the residence. The fenestration consists of original wood double-hung windows throughout the residence. The primary elevation fenestration includes wide wood shutters. The doors of the residence are non-original. The residence is in good condition. The integrity is good.


