#### P3a. Description:

The property contains a two-story single family residence with an irregular plan and wood-frame construction. A single-car garage fronts the street at ground level. Designed in the Spanish Colonial Revival style, it has low-pitched front-gable, side-gable, and conical tower roofs all clad with clay tiles. The exterior walls are clad with smooth stucco. An original entry door is situated in the first level of the tower, which is accessed via a stairwell leading from ground level. Two of three stucco chimneys are located at the exterior end or gable walls; one chimney is positioned at the rear of the residence. A pointed arched wood frame picture window defines the prominent street-facing wall. The fenestration consists of original fixed and casement wood windows throughout the residence. At ground level exists a one-car garage with shed roof clad in clay tile. The residence is in good condition. Its integrity is good.


