The property contains a one-story duplex with a rectangular plan and wood-frame construction. Designed in the Spanish Colonial Revival style, it has a side-gable roof with clay tiles and exposed rafter tails. The exterior walls are clad with smooth stucco. An inset entry porch with a low stucco wall shelters a unit entrance at each end of the primary facade. A low stucco wall delineates the property line, while a wing wall leads to the garage at the rear of the residence. The fenestration consists of original openings with non-original metal casement and horizontal sliding windows throughout the residence. The residence is in good condition. Its integrity is fair.


